- 一、為提昇本學系學生升學暨就業競爭力，依據「銘傳大學學生畢業資格檢定實施辦法」，訂定「銘傳大學商業設計學系專業基本能力檢定實施細則」（以下簡稱本細則）。In accordance with the Ming Chuan University Procedures for Proficiency-based Graduation Requirements, these regulations were established to improve students' competitiveness for their future careers and further studies.
- 二、本學系九十九學年度起入學之大學部學生，應通過本校所定之「服務學習」、「英語能力」、「資訊能力」、「中文能力」及「運動能力」畢業資格檢定標準，及本細則所定「基本能力」之檢定標準，始得畢業。研究生需通過各系所規定專業基本能力檢定標準，始得畢業。To attain graduation eligibility, undergraduate students admitted in the 2010-11 academic year and beyond must meet the graduation requirements specified in these procedures and the enforcement rules for Service-Learning, English proficiency, Information Technology proficiency, Chinese proficiency and Sports capability, as well as the professional competencies stated in these regulations. Graduate students must meet the graduation requirements for professional competency stated in these regulations.
- 三、本學系大學部學生應於在學期間內通過基本能力檢定，其項目及檢定標準

如下：Undergraduate students are required to meet the professional competencies outlined below during their period of study.

設計專題製作能力 The proficiency of executing design project	通過畢業專題設計報告書審核，並公開創作作品發表及通過審查。 The graduation design project report examination should be passed, and the creation of works should be exhibited and examined in public.
商業設計之專業能力 Specialization of Commercial Design	畢業前至少參加國內外重大設計競賽乙次（作品須經指導老師同意）。 International and domestic competitions should be taken at least once before graduation.(The works should be approved by the instructor.)

四、本學系碩士班學生應於在學期間內通過基本能力檢定，其項目及檢定標準如下：Graduate students are required to meet the professional competencies outlined below during their period of study.

設計相關領域獨立研究之能力 Independent research in design-relevant area	論文組： 1.發表期刊或研討會論文乙篇。 2.通過期中論文審查。 3.通過畢業論文審查。 Thesis Cohort: 1. Publish one paper in a journal or present in a seminar. 2. Pass midterm thesis review.

五、通過基本能力檢定標準學生，應將成績或其他相關證明文件送至本學系辦公室，經審核通過後成績以「檢定通過」登錄。Students who meet the graduation requirements for these professional competencies should submit relevant certificates or score reports to the Communications Management Department. After completion of these procedures, the students will be verified as meeting the graduation requirements.
